*WHEREAS the General Conference of UNESCO adopted in 2003 the Convention for the Safeguarding of the Intangible Cultural Heritage (hereafter referred to as "the Convention"),*

*WHEREAS the Convention and its Operational Directives define the scope and objectives of International Assistance from the Intangible Cultural Heritage Fund,*

*WHEREAS Chapter V of the Convention, as well as Chapters I.4 and I.14 of the Operational Directives, define the scope, forms, priorities, principles and procedural issues related to the granting of financial allocations,*

*WHEREAS the Intergovernmental Committee for the Safeguarding of the Intangible Cultural Heritage, by its Decision 12.COM 11.d.2, approved the allocation of a total sum of two hundred thirty-two thousand one hundred and twenty United States dollars (US\$232,120) from the Intangible Cultural Heritage Fund to Uganda for a project entitled "Community-self documentation and revitalization of ceremonies and practices associated with Empaako naming system in Uganda".*

## Article I. Purpose of the contract

Contract entered into between UNESCO and the Contractor in order to perform the following:

*In accordance with the International Assistance request entitled "Community-self documentation and revitalization of ceremonies and practices associated with Empaako naming system in Uganda" (file no. 01210), which aims to revitalize the practice of the Empaako naming system and its associated ceremonies in the five communities (Batooro, Banyoro, Batuku, Batagwenda and Banyabindi) of Western Uganda, enhance the capacities of the communities concerned to transmit knowledge and skills to successive generations, and mobilize practitioners to revive the practice, the Contractor shall:*

### 1.1 Preparation and coordination

*1.1.1 Submit by 23 February 2018 a detailed work plan of the activities to be carried out within the scope of this contract in accordance with the activities described in the above-mentioned International Assistance request, which shall be accompanied by a detailed budget estimate, both duly signed (ink signature) and presented on letterhead paper;*

*1.1.2 Ensure the procurement of equipment necessary for the implementation of the project as estimated in the approved budget;*

*1.1.3 Engage the services of the project coordination team, which includes a project manager, monitoring*
